Minutes of September 11, 2019 Executive Committee meeting approved.

#### Treasurer's Report - Joan Martin

- Rate of growth of Club programs has presented administrative challenges that need to be addressed.
  - Improve communication between rowing programs and finance related to program and reimbursable expenses in advance of action.
  - Clearly and reasonably identify the responsibilities of each role.
- Need 2020 capital expenditure budget requests from Rowing and Building committees
- 990 should be done near end of month
- Needs information about junior regatta fees need to be reimbursed before HOCR/Fish. Significant amount outstanding.
  - Dan volunteered to review race entries and compile list of rowers to be invoiced.

#### Captain's Report – Eric Watne

- Plans underway to introduce two levels of bow certification for quads A and B
  - o Eric has had discussions with Rick Richards who coaches adult quad classes
  - o Recent quad class participants B certified for older quads until more experience gained
- Purchase of Filippi demo quad
  - Demo period has ended.
  - o Filippi will sell to NBC for \$19k. Retail new would be \$33k.
  - Majority of rowing committee is in favor of buying and Eric is asking BOG to authorize purchase.
  - All NBC quads heavily used daily.
  - o Joan will need to review finances to determine availability of funds.
  - Motion by Dan to approve spending up to \$20k for purchase of shell and cover subject to availability of funds.. Kristi seconded. Unanimous approval.

John impressed with regatta success and feedback from participants.
