Meeting called to order 6:00 pm by Jamie Reavis

#### Membership Committee Report – Ruth Berenson

- Committee discussed what they felt went well in 2019 season and are developing plans to address challenges they've identified.
- Concerned about liability when alcohol is served at club functions where juniors are represent
  - Jamie commented we need to be careful as a club and not expose member-hosts to liability and asked for thoughts/suggestions.
  - Kim said social committee can setup separate drinks tables for alcohol at future events.

#### **Development Committee Report – Michael Hamilton**

- There's been a good response to year-end appeal so far. Feels we should inform membership how scholarship funds are used to accomplish NBC mission.
- Pat commented we need to do same for Annual Fund.
- Pat will prepare a follow up appeal letter to be sent before end of year

#### **Director of Rowing Report – Daniela Roop**

- Need to schedule winter engine maintenance and arrange winter storage. Asked for recommendations and feedback about past service
- Dan and John will make recommendations based on past years work performed.

#### Youth Rowing /Row Providence – Michael Hamilton

- Small group has begun looking at club's youth program in terms of who is served or underserved
  - Working to determine if program should be re-branded as more of a community rowing than a "club" program
  - Create a platform for scholarship and grant funding as financial support
- "Row Providence" is a not necessarily set as a name. For now it's a working name.
- 2019 tested some new ideas and received some positive feedback as well as criticism that it was confusing
- Determine plan to reach out to constituents (ie Providence Public Schools)
- Determine how NBC Scholarship Fund will help.
- Program will take time to develop and may roll out progressively

- Daniela spring program will start end-of-March. Planning has started and advertising will start soon
- Joan Fall target is earliest. Take tie to do it well. don't interfere w/ spring
- Anne commented there's been to much confusion already so some of this needs to be addressed sooner.
- Kim suggested soliciting coaches' feedback will be better if done sooner than later while memories are fresh

#### Building Committee / 1.66 Report – Kit Wise

- 1.66 CRMC notified him last week they'll be issuing notice of assent.
- Once assent in hand we will be ready to to real contract negations with Row America (docks) and Atlantic Marine (installation)
- Goal is to start construction once weather and contractor availability allows in the spring
- Private boat owner my need to be move their boats to make room for work. They'll be notified as time gets closer

#### **Old Business**

- Waiver: Jamie reports he and John Kennedy working to draft a global waiver and expect to have ready soon
- Roger Williams University: Daniela has spoken with RWU and is waiting to hear response. Discussion is about RWU students rowing at NBC during midday low-usage hours.

#### Banking

- Jamie We maintain our accounts at Webster Bank. John Ryan, along with Joan and Jamie, has signature on the 'Programs" (small account used to fund DOR's purchase of gasoline and supplies). It's time to remove John as signatory because he's resigned as DOR.
- Kit: Motion to remove John Ryan as signatory on Program Account. Dan: Seconded. Vote: Unanimously approved

#### **Annual Meeting**

• Jamie reported need to reschedule the annual meeting to accommodate space availability. Private homes are not large enough for annual meeting. Meeting will be at Providence Public Library Rochambeau Branch on Thursday January 23, 2019 from 6:00 pm to 8:15 pm.

#### **Sweeps Committee**

- Jamie states clarification that masters sweep committee is member committee not a BOG committee because sweeps program is a member program and that it is just forming and getting organized.
- Carol reports plan is to solicit more involvement and feedback from membership once soon.

#### **Equipment needs**

- Jamie has met with Daniela and the Bay View and Lincoln coaches to discuss equipment needs.
- The 8-seat barge restricts good functioning of programs.
- Discussion ensued about advantage to buying additional 4-seat section to add to barge. Approximate cost \$10k
- More launches and motors are needed. Approximate cost \$15k

- Bay View and Lincoln interested in access to a LTR 8 and expressed interest in using the Gross if it can be repaired.
  - Discussion ensued & it was agreed to let Daniela follow up to determine if repair is practical.
- Joan \$3,500 already set aside from 2019 to replace engine stolen a few months ago. We can fund balance of both purchases with 2020 budget allocation for equipment. Recommends prepaying Stillwater to obtain discounted price which exceeds earnings of money in bank.
- Kit: Motion to purchase barge section, two launches, two new motors, and one used motor. Ruth: Seconded. Vote: unanimously approved

## ROWING COMMITTEE REPORT January 23, 2020

# The NBC Rowing Committee oversaw the following initiatives/acquisitions/activities in 2019:

- Held regular new member orientations
- Several member boat maintenance events
- Regularly tested applicants for B sculling rating
- Oversaw offsite (third party) upgrades to 4 NBC team boats
- Purchased new equipment; oars, racks, motors, launch
- Purchased new rowing equipment; 4X, barge, 4-
- Refitted 4+ to coxed 4X's
- Ordered 2 new Peinert Zephyrs for spring 2020 delivery
- Increased private oar storage with new rack configuration
- Maximized boat storage with new outdoor rack configuration/racks
- Codified policies for off-site boat use

#### Goals for 2020:

- Continue to maximize available equipment storage space
- Work with the new Fleet Manager to institute and oversee more rigorous boat damage policy
- Determine and maintain mix of boats and equipment to reflect membership rowing needs
- Continue to monitor boat condition and usage to determine boats for overhaul or sale.
- Explore fleet leasing structure to distance reliance on more fragile boats to more sturdy club boats and also afford more regular turnover.
- Improve Policy's & Procedures language to more clearly reflect NBC rowing and boat usage policy
- Revisit and, if necessary, modify NBC cold water rowing policy
- Assist in revising Master and Junior boat use policy to reflect updated programmatic changes.
