Narragansett Boat Club Board of Governors meeting May 12, 2021 6:15 pm Virtual via zoom

The meeting was called to order at 6:15 pm by Jamie Reavis.

Approval of Minutes

• Minutes from the April 14th, 2021 BOG meeting were approved.

Review of Committee Reports

President's Report (Jamie Reavis)

 Dan Gorriaran has resigned from the BOG for personal reasons. Jamie thanked him for his service and asked the BOG to consider whether we should fill his position for the remainder of this year. The current constitution is a little unclear about this issue. (Officers do need to be replaced; other BOG positions aren't mandated to be filled.) After some discussion, consensus was reached to leave the position open.

Secretary's Report (Sherri Nelson, Deb Chute)*

- As of May 7th, 188 total members. Decrease of 30 overall from this time last year.
- Two new members were voted in: John Dunn (Regular), Amick Sollenberger (U23)
- Deb Chute has sent out three email reminders to sign waivers for 2020; 15 remain unsigned. It was agreed that rowing privileges should be suspended for those who have not signed waivers. Jamie will touch base with Deb about this.

Treasurer's Report (Joan Martin)

• Joan was unable to attend tonight's meeting; no financial reports for this month.

Captain's Report (Eric Watne)

• Rowing Committee is discussing modification of cold-water rowing rules; nothing radical. Their recommendations will be brought before the BOG with a plan of

implementing for this fall / winter. Jamie noted that it is incumbent upon us as a Board to consider safety issues.

Program Committee Report (Daniela Roop / Joan Martin / Kristi Wharton)*

- Adult classes have been going well. Nine youth rowers are going to Northeast regionals this coming weekend.
- Stem to Stern is coming along; we've received some generous donations. There was a question regarding what are the main costs: Kristi responded to a question regarding the main costs: transportation, and program coordinator for the summer. All of the STEM components are completely volunteer and we most likely wouldn't need a program coordinator for the academic year as the plan is for the kids to be part of the NBC programs. The program is starting small and building incrementally.

Governance Committee Report (Alan Harlam)*

- The committee made its way through a "tall pile" of comments on the draft of the amended constitution and incorporated them into the document; they shared the document with the membership and wrote a "decoder key."
- Next steps:
 - o Comments on updated draft due by May 19th
 - Town hall on May 25th (moved from May 26th)
 - To comply with the current constitution's requirements for amending the document, seven members need to sign the proposed document for presentation at the quarterly meeting in July. No changes would be made after that point.
 - The document would be voted on in the next quarterly meeting in October.
 - If changes were to be made after the July presentation, it would need to be presented again (in October), and voted on three months later.
 - In response to a concern raised in a couple of comments that have been submitted, Alan noted that power rests with the membership to elect the BOG, approve the budget, and make changes to the constitution; the membership delegates all other duties to the BOG to run the club day to day, and that our policies is the way that day to day governance is done in the club. He noted that the committee has strived to follow the Strategic Plan and incorporated research from the constitutions of multiple organizations in their development of this document.

Development Committee (Pat Watson)

- Pat reported that she plans to to report out to donors in a letter this summer how money was used, in terms of unrestricted donations.
- Eric Watne added a request: if you donated something for the auction, email him with the value of the item, since it's a charitable donation.

Membership Committee (Ruth Berenson)

• The first committee meeting in a long time is schedules for May 20th; everyone is invited. She has reached out to new BOG members to attend the meeting. She would like to reinstitute member breakfasts if current Covid restrictions allow.

DEI Committee (Marlene Yang / Susan Burgoyne)

• First meeting May 26th

Facilities

• Contractor will come in the next couple weeks to make repairs on windows.

Old Business

• Sweeps and Sculls Regatta (Kristi Wharton)

July 31st is the date for the regatta. Committee members include: Eric Jones, Susan Faasse, Rob English. Many volunteers are needed; let Kristi know if you want to get involved in planning. Registration will open on Regatta Central on May 22nd. There was discussion re how current Covid guidelines would affect the regatta, e.g. re number of participants, and what we can ask about and how we would monitor issues such as vaccination status, Covid testing; requirements for masks; social distancing. The upshot is that the committee will come up with tentative recommendations, incorporating US Rowing guidelines and current state guidelines, and present these recommendations to the BOG. Currently all the usual entries are included for the regatta on Regatta Central. There was agreement that it is a moving target, and we will need to be flexible and potentially make changes as the date gets closer. Fortunately, Regatta Central allows for refunds close to the regatta date. Send any questions or concerns to Kristi. A related question arose re reintroducing bigger team boats at the club, and the Programs Committee is discussing this.

New Business

• Boathouse cameras (Jamie Reavis)

Jamie noted requests today on google groups asking about bringing boathouse cameras back online. Pete agreed to take this on in the Facilities committee, along with the weather station. People have volunteered to donate the materials; it will take a couple weeks to get things up and running.

• Planning Committee / Strategic Plan (Jamie Reavis)

This was discussed because Dan was the chair of this committee and is no longer on the BOG. Jamie raised the issue of whether we should keep the committee, as it has not been very active. Alan noted that the constitution doesn't list any standing committees; it was defined as a standing committee in the strategic plan. Furthermore, standing committees are not specified in the new constitution, so this would be a BOG decision. After some discussion, the consensus was reached that the Planning Committee is not

necessary, but we do need to monitor whether we are reaching the goals set out by the Strategic Plan. If we aren't hitting certain targets, we should have justification for that. Kristi suggested that one committee chair at a time each month discuss where they are on the Strategic Plan. Whichever committee is up for that month submits a brief written report to be distributed in meeting materials. Facilities is up first.

• Future Meetings (Jamie Reavis)

The question has arisen re whether to resume meeting in person vs stay on zoom. Several said stay with zoom; it provides more access for members, and is also easier for BOG members in case of travel, other responsibilities. Consensus: stay with zoom.

Remarks for the Good of the Club

There is an Open house this Saturday May 16th. It's great that we are talking about holding a regatta given there wasn't one in 2020. And stay tuned for a HOTS late in the fall (Scott Whitney would like plan this).

Narragansett Boat Club Programs Committee Report June 2021

Since our May report, Scott Whitney and Wes Kerns have joined the committee. We have decided not to fill the Head Youth Coach position previously held by Tom McAlaine (who has returned to Philadelphia). Beginning May 17th, the team of Daniela Roop, Joan Brush, and Kim Worrell assumed the responsibilities of running the youth programs. This has been working quite well and we are very optimistic for a terrific season.

Adult Rowing Programs Report:

NBC hosted an open house May 15th and had nearly full barges for each of the 3 sessions from 9-12. Most of the folks that attended either registered for classes or were already registered and couldn't wait to get on the water. It was a great calm sunny day and Emi Marchetti did a great job driving the barge and providing instruction. Eric W, Daniela R and Kim W were also on hand to give tours, answer questions and help with the rowing.

The Adult Rowing Programs second spring session (**Session #2**) commenced the following Monday (week of May 17th) and will be ending June 25th after a 6-week run. Between Barge, Zephyr, Team boat rowing, intermediate and advanced sculling we have approximately 95-students enrolled in 11 different classes.

Session #3 will be starting June 28th and should be going up on MindBody in the next 2 weeks. While the details are still TBD it is hoped that included in the Session #3 offerings will be sweep rowing opportunities.

NBC Youth Programs Report:

We are halfway through the Spring Session 2 which ends June 25th. Enrolled are a total of 52 youth rowers: 7 Beginners, 7 Intermediate 1s, 13 Intermediate 2s and 25 Advanced.

Our end of Spring Youth Intra-squad regatta, named the <u>Red Bridge Regatta</u> will be held Friday, June 18th, 2021 – one week before the end of the session due to the fact that 2 of our elite rowers (Lily Sarnowski and Ben Kerns) will be leaving to attend the USRowing Olympic Development Program in Florida.

We are still waiting to hear more details from USRowing regarding their Summer National Championships Regatta, July 13-18th in Camden, NJ. We should have a good

number of young rowers wanting to compete at this regatta in their U19 and U17 events.

The Summer Sessions are open for registration for both the Recreational 2 week classes and the Competitive 4 week training programs. They will all be run between 7:30 am and 11 am. The Summer Sessions start Monday, June 28th and will run until August 20th.

I would like to thank all of our talented and dedicated coaches: Joan Brush, Kim Worrell, Fran O'Donnell, Georgia Jones and Sarah Fiske, and the coaches who have so kindly occasionally subbed in for us: John Ryan, Anne Fleet and Robin Gross.

NBC/Brown STEM to Stern Program Report:

As of June 6th, 2021, we have received a \$10,000 grant from an anonymous donor and \$1,650 in other donations for the NBC/Brown STS program. Huge thanks to all who have donated!!

We received 5 sets of sculling oars from C2 – we appreciate their generosity. Thank you!

As of right now we will run two 2-week NBC/Brown STS Learn-to-Row sessions with 9 middle school participants per session who are enrolled in summer programs at East Providence Boys & Girls Club. EPBGC will be providing transportation, swim tests, and a contribution for each student who participates, to help defray costs.

Dates: July 12-23 & July 19-30 Rowing (at NBC) 9:30-11:00AM STEM projects (at Lincoln School – thanks to Sophie Lau) 11:15 – 12:30PM

We are hoping to hold another session with students from the Cuffee MS pending available transportation. Example of cost: Ocean State Transit and others charge \$4000 for 8-10 students for a 2-week session. We are trying to be creative and considering other options.

Thanks to Kiana Anderson and Duuluu Naranbat for their help!! For the STEM component, we are working with John Santiago and Sawyer Smith at Brown, and Rachel Hunter from STEM to Stern. Brown graduate students and others have offered to volunteer their time to work with the STS students.

Kiana Anderson, George Lawton, and Limor Dubrovsky (Brown Crew) are recruiting college rowers who will help with coaching

Please contact Kim, John or Kristi if you are interested in getting involved.

Brown Crew will launch a large national fundraising campaign from September until the HOCR. Paul Cooke, George Lawton and Limor Dubrovsky are working to coordinate this event.

Rick Richards and Virginia Hopkins worked the Cuffee school to provide a swimming (through Swim Empowerment at Pawtucket Y), erging and rowing for 7 Cuffee MS student this spring.
